**XII. REPORTS & PRESENTATIONS**

- a. Proclamation for Malik Melson - *Councilwoman Tammy Grimes*

Councilmember Tammy Grimes gave an introduction of Malik Melson and presented him with a Proclamation. Councilmember Grimes shared how 10 year old Malik wanted to feed the homeless for his birthday, is always eager to help with his community and is a great example for others his age.

- b. Proclamation for Salem Middle School Lions - *Councilwoman Tammy Grimes*

Mayor Pro Tem George Turner congratulated the Salem Middle School Boys Baseball Team and presented two members of the team with a Proclamation. The Salem Middle School Lions are the Dekalb County School District Middle School Boy's Baseball Champions, ending their baseball season with 14 wins and 2 losses.

- c. Proclamation for Willie Hinton - *Mayor Pro Tem George Turner*

Mayor Pro Tem George Turner shared how Mr. Willie Lee Hinton Jr., who passed away on March 20, 2022 was a pillar in the community. He shared some highlights of his life, his accomplishments and read the Proclamation from the City that will be presented to Mrs. Hinton.

- d. Former Board Appreciation - *Mayor Pro Tem George Turner*

Mayor Pro Tem George Turner wanted to acknowledge each former Board Member of the City for their service. Although conditions do not permit the opportunity to present as envisioned, the Presentation was delivered virtually. The City Council will plan to invite all former members to join in the Chambers at a later date for an additional show of appreciation.

The Presentation honoring some of the City's Former Board and Committee members was presented by Deputy City Clerk Aisha Harris.

### **XIII. OLD BUSINESS**

- a. **For Decision** - Financial Management Policy Revision - 2nd Read - *Gia Scruggs*

Finance Director Gia Scruggs brought the 2nd Read of the Financial Management Policy Revision with the proposed changes that were discussed April 25, 2022. The preamble of the Ordinance was read by the City Clerk.

**Motion** - made by Councilmember Rob Turner to approve the Financial Management Policy Revision. Seconded by Councilmember Tammy Grimes.

**Motion passed unanimously.**

- b. **For Decision** - Final Cooperation Agreement with the East Metro DeKalb CID - *Jonathan Bartlett*

Economic Development Director Jonathan Bartlett provided a brief overview. During the December 20, 2021 City Council Meeting the City Manager was authorized to enter into a Cooperation Agreement with the East Metro CID and a draft of the agreement was approved. East Metro CID identified a couple of minor changes requested of the City and Mr. Bartlett is bringing the agreement back to Council for review.

The substantive change that has been made requests the City accept notice of one week instead of two weeks. The Committee recommends copies of this Resolution be sent by US Mail to members of the East Metro CID that has property in the City of Stonecrest. This amounts to 112 property owners.



**Motion** - made by Councilmember Rob Turner to approve the Final Cooperation Agreement with the East Metro Dekalb CID. Seconded by Councilmember Tara Graves.

#### XIV. NEW BUSINESS

- a. **For Decision** - TMOD 22-008 - Adult Day Center - *Keedra Jackson*

This item was approved in the Public Hearing.

- b. **For Decision** - TMOD 22-005 - Towing & Wreckage Services - *Keedra Jackson*

This item was addressed in the Public Hearing and deferred to the next City Council Meeting.

- c. **For Decision** - RZ-22-001 - Hunter's Ridge Rezoning - *Keedra Jackson*

This item was approved in the Public Hearing.

- d. **Update** - Announcement of Municipal Court Fee Schedule - *Mallory Minor*

Announcement of Municipal Court Fee Schedule presented by Municipal Court Clerk Mallory Minor. Court Clerk Minor shared the Public Announcement and reviewed the Schedule of Fees for services provided by the Municipal Court.

No action required. Court Clerk Minor will come back to Council in 45 days to request approval. A Resolution will be presented at that time.

The Fee Schedule will be posted on the City's website and objections must be submitted within 30 days of posting. The fees must be in writing by electronic communication and forwarded to the City Attorney, Mayor and City Council.

- e. **For Decision** - Establishment of Charter Commission - *Mayor Pro Tem George Turner*

Mayor Pro Tem George Turner stated it is the Council's intent to call for the Charter Commission officially by adopting a Resolution. Mayor Pro Tem read the draft Ordinance's preamble.

**Motion** - made by Councilmember Rob Turner to adopt the Resolution for creation of a Charter Commission for the City of Stonecrest. Seconded by Councilmember Tara Graves.

**Motion passed unanimously.**

There are eight members, one from each Council member, one from the Mayor and one from each branch of the Georgia General Assembly. The City Attorney will serve as an ex-officio member.

- f. **Update** - Metro Green Update - *Attorney Winston Denmark*

Attorney Denmark gave an update on the Metro Green litigation. Attorney Denmark confirmed there was an order issued by Judge Tangela Barrie of Superior Court to cease concrete crushing and all other activities. These are preliminary orders and determinations. As long as the litigation is ongoing, this order is in effect.

## **XV. CITY MANAGER UPDATE**

### **a. COVID Update**

City Manager Janice Allen Jackson gave a COVID update. There is a rise in the number of cases in DeKalb County. City Manager Jackson is encouraging everyone to remain cautious and practice social distancing.

### **b. City Hall Reopening**

City Manager Janice Allen Jackson confirmed City Hall is open for business. If you would like to meet with someone specific, staff requests you make an appointment at this time to confirm the needed staff is available.

### **c. Survey**

City Manager Janice Allen Jackson confirmed the ARPA survey is on the City's website and will be available thru June 18, 2022. All residents and business owners in the community, as well as stakeholders are invited to complete the survey. The City is interested in what citizens and business owners consider are the greatest needs of the City of Stonecrest.


